IT PROVIDES 'POWERSACKS' TO OVER 1,600 STUDENTS FROM THE DENVER PUBLIC ELEMENTARY SCHOOLS TO NOURISH THE STUDENTS AND THEIR FAMILIES. THEY CONTAIN FOOD TO FEED A FAMILY OF FOUR OVER THE WEEKEND. EACH FRIDAY DURING THE SCHOOL YEAR STUDENTS FROM METRO STATE UNIVERSITY OF DENVER JOIN OTHER VOLUNTEERS TO PACK THE INDIVIDUAL SACKS WITH APPROXIMATELY 3 TONS OF FOOD ORDERED EACH WEEK.

THE FOUNDATION HAS COLLECTED AND REPAIRED BOOKS AND PAID FOR THE SHIPMENT OF THOSE BOOKS AND OTHERS COLLECTED BY SCOPE TO KENYA FOR LIBRARIES THERE. IT HAS ALSO FUNDED CLEAN WATER PROJECTS IN THE SAME AREA. AN ARVADA SUNRISE ROTARY CLUB ROTARIAN TRAVELS THERE SEVERAL TIMES A YEAR TO OVERSEE THE PROJECTS.
